4. Local Authority Collections

CRE: Provided an overview of current situation with SBC and ran through the collections per local authority, before opening to questions

JE: Provided overview of collection as per ERYC statutory duties and raised the disparities between ERYC and SBC with SBC not following the collection procedures. Additional information was provided re a council meeting, with a point raised about hardship

JH: Requested an update from CRE re his meeting with SBC and how the situation will be resolved.

CRE: Provided background as to when YCBID became aware of SBC non-collection of the BID Levy and steps taken to resolve, including court dates.

CRE: Provided additional information regarding VAT query, inclusive of external advice sought.
